

DONATION CONDITIONS FOR SMUFFI PETS USERS:

THESE CONDITIONS SHALL APPLY TO THOSE PERSONS, NATURAL OR LEGAL, WHO DECIDE, IN GOOD FAITH AND VOLUNTARILY, MAKE CONTRIBUTIONS OR DONATIONS TO ANY OF THE INSTITUTIONS OR SHELTERS EITHER IN THE PROCESS OF CERTIFICATION OR THAT ARE RECOGNIZED AND CERTIFIED BY SMUFFI PETS , AND WHICH WILL BE ANNOUNCED THROUGH THE LIST PUBLISHED ON OUR APP AND/OR WEBSITE; LIKEWISE , THESE CONDITIONS OF DONATION , ARE ANCILLARY AND COMPLEMENTARY TO OUR TERMS AND CONDITIONS, AND ARE SUBJECT TO THEM, THEREFORE, WILL BE SUPPLETORY IN THE CASE OF LOOPHOLES, INTERPRETATION OR DOUBT.

1 DONATIONS ARE VOLUNTARY AND IN GOOD FAITH, THUS IT IS A COMMITMENT THAT THE USER WILL ACQUIRE IN SELF-DETERMINATION, CONSCIOUSLY AND AS A CONFIDENT VOTE AND SUPPORT IN FAVOR OF THE INSTITUTION OR ANIMAL SHELTER BEING SUPPORTED, THEREFORE THEY WILL DETERMINE WHEN THE DONATIONS STOP.

2 SMUFFI PETS RECOGNIZES TWO TYPES OF DONATIONS:

- a) TIME: BEING UNDERSTOOD AS VOLUNTEER ENROLLMENT, CARRIED OUT BASED ON WEEKLY HOURS OF WORK OR AID IN TASKS FROM THE INSTITUTION OR ANIMAL SHELTER TO WHICH THE DONATION IS DESTINED TO. THIS DONATION SHALL NOT BE LESS THAN TWO HOURS PER WEEK, AND THE VOLUNTEER MUST PRESENT HIMSELF DIRECTLY AT THE FACILITIES OR IN COORDINATION WITH THE INSTITUTION, SO THAT THE ACTIVITIES UNDERTAKEN IN VOLUNTEERING, AND THE RESPECTIVE CALENDAR, WOULD BE ORGANIZED BY AGREEMENT BETWEEN THE INSTITUTION OR SHELTER AND THE DONOR.
- b) FINANCIAL CONTRIBUTION, TRANSLATED IN CONSUMABLE GOODS BY SMUFFI PETS: THE USER MAY CHOOSE TO FINANCIALLY SUPPORT THE SHELTERS OR INSTITUTIONS OF THEIR CHOICE, MEETING THEIR NEEDS FOR FOOD, DRUGS AND ACCESSORIES (OVERALL "CONSUMABLE GOODS"), IN SUCH A MANNER THAT THE USER IS FREE TO CHOOSE THE AMOUNT OF DONATION, FROM A MINIMUM OF 1 USD, TO THE ANIMAL SHELTER OR INSTITUTION. THEY RESOURCES AVAILABLE AT THE ACCOUNT, WILL BE ABLE TO BE EXCHANGED, AT HIS CHOICE, FOR CONSUMABLE GOODS CONTAINED IN OUR CATALOGUE, WHICH HAS BEEN CREATED ESPECIALLY TO FULFILL THE NECESSITIES OF THE INSTITUTIONS AND SHELTERS, AND WILL CONTINUE TO EXPAND.

3. IN RELATION WITH THE FINANCIAL CONTRIBUTIONS, PLEASE BE INFORMED THAT, ON BOTH OUR MOBILE APP AND OUR WEBSITE, THE OFFICIAL CURRENCY IS THE UNITED STATES DOLLAR (USD), THEREFORE, ALL THE DONATIONS WILL BE ADJUSTED ACCORDING TO THE CURRENT EXCHANGE RATE AT THE TIME OF THE DONATION, FOR EACH COUNTRY.

4. THE EXCHANGE OF GOODS, ON BEHALF OF INSTITUTIONS OR ANIMAL SHELTERS, THAT THE USER DECIDES TO DONATE, WILL BE DOLLAR PER DOLLAR, DEPENDING ON THE FINANCIAL RESOURCES AVAILABLE AT THE ACCOUNT. SMUFFI PETS IS ONLY AN INTERMEDIARY BETWEEN THE INSTITUTIONS OR ANIMAL SHELTERS AND THE DONOR USER, TO THIS EFFECT, WE REITERATE THAT THE SYSTEMS AND PAYMENTS ENGINES, AND THE ONLINE SHOPS (I.E. APP STORE OR GOOGLE PLAY) ARE INDEPENDENT TO US AND THE COMMISSIONS CHARGED BY THEM, HAVE BEEN COVERED THANKS TO THE COMPETITIVE PRICES OBTAINED BY THE CONSUMABLE GOODS SUPPLIERS.

5. IN GENERAL, THE DELIVERY OF GOODS SELECTED BY THE SHELTERS OR INSTITUTIONS IS OUR RESPONSIBILITY AND WE WILL COMPLY THROUGH THE PROCUREMENT OF THE NECESSARY LOGISTICS AND SHIPPING COMPANIES. WITH SPECIFIC REGARD TO DRUGS, THESE WILL BE SENT THROUGH LABORATORY AND / OR DISTRIBUTORS AUTHORIZED BY THE CORRESPONDING HEALTH AUTHORITIES OF EACH COUNTRY.

6. THE RESPONSIBILITY OVER THE QUALITY AND GUARANTEE OF THE GOODS IS BORNE ENTIRELY BY THE PRODUCERS, HOWEVER, WITH THE FIRM INTENTION THAT THE DONATIONS ARE THOROUGHLY TAKEN ADVANTAGE OF, WE INVITE YOU TO NOTIFY OF ANY NEWS THAT MAY BE IN REGARDS TO THEM, SENDING AN EMAIL TO SUPPORT@SMUFFIPETS.COM.

7. INSTITUTIONS OR SHELTERS TO WHICH A USER DECIDES TO DONATE, WHETHER IT'S TIME OR A FINANCIAL CONTRIBUTION TRANSFORMED INTO GOODS, MAY DECIDE, OR NOT, TO SEND A THANK YOU MESSAGE TO THE DONORS THROUGH THE SMUFFI PETS ADMINISTRATION PANEL.

PLEASE BE INFORMED THAT, ON BASE WITH THE SMUFFI PETS POLITICS, ALL THE DONATIONS MADE THROUGH FINANCIAL CONTRIBUTIONS, WILL BE TRANSFORMED INTO CONSUMABLE GOODS, BASED ON THE REQUIREMENTS AND NECESSITIES OF EACH INSTITUTION OR SHELTER. LIKewise, WE INFORM YOU THAT OUR FUNCTION IS AS INTERMEDIARY BETWEEN DONORS AND INSTITUTIONS AND SMUFFI PETS DOES NOT CREATE OR CONFER TAX DEDUCTIBLE RECEIPTS FOR THE DONATIONS.
